Survey on the gradual reopening of businesses after the COVID-19 outbreak

(last update - 12 May 2020)

On **24** April **2020**, HOTREC sent a survey to its Members on the **gradual reopening of hospitality businesses at national level** after the COVID-19 outbreak.

31 HOTREC Members from 24 European countries replied to the survey so far.

Question 1 – How many hotels are closed (rough percentage rooms or numbers) and when do you expect closed hotels to start reopening? What are the occupancy rate in opened hotels?
