

Lockdown and emergency measures in Europe – current state of play (Update 26/01/2022)

Notes:

- In general, distances of 1.5 metres must be kept as part of physical distance measures. This document only specifies where there are different national requirements.
- In general, masks must be worn in closed public spaces. This document only specifies additional or lesser national requirements.
- The EU Digital Covid Certificate entered into force on 1 July 2021. Certificates certifying an individual's vaccination, recovery or test results are delivered nationally but rendered interoperable at EU level. Most European countries require individuals to show a certificate to enter certain establishments or attend events. EU Digital Covid Certificate holders also face much lighter, or no restrictions for intra-EU travel, and several countries only authorise entry to travellers with proof of vaccination, recovery or negative test.
- On 13 October 2020, the Council adopted a <u>Recommendation to facilitate travel and coordinate restrictions</u>.
- On 25 November 2021, the Commission proposed to update the rules on coordination of safe and free movement in the EU.
- On 26 November 2021, EU countries met in an emergency high-level IPCR roundtable to coordinate the EU response to the emergence of the new COVID-19 Omicron variant
- On 17 January 2022, the Council updated the list of third countries for which COVID-19 travel restrictions should be lifted.
- On 25 January, the Council adopted a <u>Recommendation on a coordinated approach to facilitate safe free movement during the COVID-19 pandemic</u>. Under the new recommendation, COVID-19 measures should be applied taking into account the status of the person instead of the situation at regional level, with the exception of areas where the virus is circulating at very high levels. This means that a traveller's COVID-19 vaccination, test or recovery status, as evidenced by a valid EU digital COVID certificate, should be the key determinant. A person-based approach will substantially simplify the applicable rules and will provide additional clarity and predictability to travellers.
- Figures for infection rates over the past 14 days per 100.000 inhabitants in countries covered by this document were gathered on 24 January 2022.
- Click <u>here</u> to read the last **overview report** (20/01/22) from the European Centre for Disease Prevention and Control. **Due to the fast extension of the Omicron variant, cases have** raised almost in every country. The overall COVID-19 case notification rate for the EU/EEA (2621/100.000 population last week) has been increasing for four weeks. However, the 14-day COVID-19 death rate (48.5 deaths per million population, compared with 50.5 deaths the previous week) has been stable for eight weeks. While hospital admissions have tended to increase, the number of ICU patients remains stable or is declining.
- On the other hand, <u>on 11 January the European Medicines Agency's</u> (EMA) Head of Vaccines Strategy, Marco Cavaleri expressed **doubts about the need for a fourth booster dose** of COVID-19 vaccine pointing out that "repeated vaccinations within short intervals would not represent a sustainable long-term strategy". Moreover, according to EMA, "the spread of the **Omicron variant is pushing COVID towards being an endemic disease that humanity can live with**, although it remains a pandemic for now". In the same direction, <u>on 22</u>
 <u>December WHO Director-General warned</u> that <u>booster dose programs "are likely to prolong the pandemic, rather than ending it</u>" because they would divert supply to places with already high vaccination coverage and allow the virus to continue to mutate elsewhere. In sum, "No country can boost its way out of the pandemic".
- 81,1% of the population above 18 years of age and 69,7% of all the population is fully vaccinated. <u>814,5 million vaccination doses</u> have been administered. Vaccination figures in this document cover the total population.



Infection rate (cumulated past 14 days): 2881 cases per 100.000 inhabitants (up from 565 cases per 100.000 inhabitants on 20 December 2021).

On 21.01.2022, 75,4% of the population received at least one dose of Covid-19 vaccine and 72% of the population is fully vaccinated.

Covid Certificate: the 2G-rule (vaccinated, recovered) applies. Visitors should be aware that persons who are not vaccinated or recovered can only leave home for essential reasons. For everyone else, a certificate of vaccination or recovery is required to access any indoor venue.

On 23.01.2022 47,3% of the population have taken an additional dose. Attention: The 1-dose vaccine by Johnson & Johnson requires a booster since 3 January 2022.

General information: Non-essential shops are open but the 2G-rule applies. Events with unassigned seating are permitted for up to 25 persons. Where there is assigned seating, up to 500 persons can gather. If all participants provide proof of vaccination or recovery, plus a negative PCR test (72 hours), events for up to 1,000 persons are permitted. If all participants have proof of booster shots, events are permitted with up to 2,000 persons. At all indoor events, FFP masks or the equivalent must be worn. Closing time is 10pm. Stricter rules may apply at the regional level.

FFP2 masks or equivalent must be worn in all public transport, as well as at stations/stops (indoors), in taxis and vehicles of taxi-like companies. For passengers of cable cars and ski-lifts, the 2G-rule applies. FFP2 masks or the equivalent must be worn. The 2G-rule does not apply when the cable-car is used to cover the needs of daily life.

A national '<u>Corona Traffic Light</u>' is in place, assigning each Austrian district to one of 5 categories. A contact tracing tool <u>Stopp Corona App</u> is available. Protocol for hospitality: <u>Safe hospitality</u>

Hotels: Accommodation establishments are open. The 2G-rule applies and comprehensive health measures are in place. FFP2 masks or equivalent must be worn indoors in common areas. Stricter rules may apply at the regional level.

Bars and restaurants: Catering establishments are open but have a curfew at 22h. The 2G-rule applies, guest need to be registered and FFP2 masks or equivalent must be worn indoors. Stricter rules may apply at the regional level. Nightclubs: clubs will remain closed until further notice.

Traveling restrictions:

Austria has tightened its entry rules due to the outbreak of the Omicron variant: Travel for touristic purposes is possible for vaccinated and recovered people. However, additional documents may be required. To enter Austria, the **"2-G+"** rule is currently in place. **In addition to proof of vaccination/recovery**, you need a negative **PCR test** OR **proof of a booster jab**. If these requirements are not met, registration must take place and a ten-day quarantine must be initiated immediately.

COVID certificate: The "<u>Covid Safe Ticket</u>" was introduced on 13.08.2021 and is required to access public spaces, such as bars and restaurants, fitness centres, museums, swimming pools, large events, etc. A Covid Safe ticket must document if a person has been fully vaccinated against, has been previously infected with, or has tested negative for COVID-19. Belgium's regional authorities (<u>Flanders</u>, <u>Wallonia</u>, <u>Brussels Capital Region</u>, <u>German-speaking community</u>) can implement specific territorial regulations.

Covid-19 pass validity and boosters: on 23.01.2022 54,1% of the population have taken an additional dose

The booster vaccine will be added to the Covid Safe Ticket from March 1. The Consultation Committee considers that "A booster dose is an important protection against the virus" and, "Consequently, (the Consultation Committee) decided to extend the period of validity of the vaccine certificate".

General information: the Consultation Committee has approved the **corona barometer**. The corona barometer is intended as a tool for proactive policy preparation and communication and should offer more predictability to the sectors concerned, structure the decisions of the Consultation Committee and make them more transparent. Code yellow, orange and red The corona barometer has three phases that reflect the level of pressure on healthcare: - yellow code: epidemiological situation and pressure on hospitals under control; - code orange: increasing pressure on the health system, requiring intervention to reverse the trend; - red code: high risk of overloading the health system.

The barometer-based measures will come into effect on Friday, **January 28 under code red**. The Consultation Committee notes that the number of contaminations continues to increase sharply. The reproduction rate of infections and hospitalizations remains above 1, indicating increased spread of the virus. The number of hospitalizations is also increasing, while the number of intensive care beds occupied by covid patients is still slightly decreasing, which reflects the characteristics of the omicron variant, which is less pathogenic but clearly more contagious.


The Consultation Committee has decided to launch the code red barometer from 28 January with the following measures:

Public events like plays and football matches will be allowed indoors and outdoors, with the exception of dynamic indoor events like dance parties. Wearing a mask is compulsory for everyone inside and outside. The CST is mandatory from 50 participants indoors and 100 participants outdoors. A capacity of up to 200 people is still allowed. An occupancy rate of 70 or even 100% is authorized for the largest rooms provided that the air quality is maintained below 900 ppm. Weddings and funerals are permitted as at present.

Organized group activities such as youth movements, associative life and the practice of sport at a non-professional level are authorized. The maximum capacity is 80 people inside and 200 people outside. Regarding the camps, overnight stays are authorized.



Opening of a series of indoor activities with the exception of nightclubs and dance halls, the following indoor spaces, currently closed, can reopen to the public: amusement parks, indoor playgrounds, animal parks and zoos, subtropical swimming pools and recreational parts of swimming pools, trampoline parks, bowling alleys and darts halls, snooker and billiard halls, paintball centers, laser games, escape rooms, casinos, automatic arcades and betting shops. Telecommuting, shopping and wearing a mask Current measures regarding teleworking (four days a week), safe shopping and wearing a mask remain in effect.
Hotels: All forms of accommodation (including hotels, aparthotels, gîtes, B&Bs, holiday parks and campsites), including their restaurants and bars, are open, subject to compliance with the measures and protocols in force.
In Brussels, a <u>safety label</u> has been developed to reassure visitors that the site, venue or establishment in question is safe. The criteria for receiving such a label are based on checklists drawn up on the basis of specific protocols, developed in close cooperation with sectoral entities and representatives. Information for the other regions is available at: <u>Health protocols for Flanders</u> (in Dutch); <u>Health protocols for Wallonia</u> (in French).
Bars and restaurants: the closing time for the Horeca is extended to midnight. Wearing a mask remains applicable for customers and staff and the CST is mandatory. In addition, the rules concerning the capacity of 6 people per table and the ban on eating standing still apply. The nightlife and discos (indoor/dynamic) remain closed.
Travel restrictions: all travellers must fill it in within 6 months before entering Belgium. To determine the quarantine measures, the PLF will take into consideration the areas where you have been in the 14 days before travelling. If the zones have changed colour, measures will apply retroactively.
Entry requirements depend on the colour attributed to the country of departure, according to Belgium own national <u>classification of risk areas</u> : green, orange, or red areas. All travellers aged 12 and older can enter Belgium if their 'EU Digital COVID Certificate' contains one of the following:
 Proof of full vaccination, completed at least two weeks before travelling. Accepted vaccines: vaccines <u>authorised by the European Medicines Agency</u> (EMA): Comirnaty (BioNTech and Pfizer), Moderna, Vaxzevria (AstraZeneca/Oxford), Janssen and Covidshield.
• Proof of recovery from COVID-19. Validity: 180 days.
 Negative molecular or antigen test result. Validity: 72 hours (PCR) and 36 hours (antigen).

Covid-19 pass validity and boosters: on 24.01.2022 8,3% of the population have taken an additional dose

General information: as of December 1, 2021, Bulgarian authorities have introduced a set of <u>restrictions</u> (in Bulgarian) valid until 31 March 2022. Wearing a facemask is also mandatory in crowded open spaces, whenever it is not possible to maintain a physical distance of 1.5 metres from other people.

Visits to shopping malls and centres, shops with a net retail area of over 300m2, bazaars and indoor exhibitions are allowed only if all participants, including staff, hold a valid EUDCC or equivalent document. **Exceptions**: grocery stores, pharmacies, medical and vaccination establishments, drugstores, opticians, pet shops, banks, postal and courier service providers, insurers, payment service providers and telecommunications operators' office (including those located inside a shopping mall).

The following activities are **suspended**:

- Group activities in children centres and clubs.
- Team buildings and professional group activities.
- Mass events, such as music and folklore festivals, concerts, fairs, etc.
- Collective sports indoors, with the exception of trainings and competitions for registered athletes at licensed sport federations. Sports competitions for registered athletes at licensed sports federations are allowed.

<u>ViruSafe</u> is used to track and trace through a daily tracking for symptoms and health status with a voluntary GPS-based functionality. <u>Health protocols for</u> tourism services and tourists (in English).

Hotels are open, the 3G rule applies.

Bars, restaurants and cafés: are open in a limited capacity and the 3G rule applies.

Travel restrictions: Documents required depend on the colour attributed to the country of departure, according to Bulgaria's own national classification.

The 3G-rule applies for travellers from green and orange countries.

The 2G – rule applies for travellers from red countries (according to Bulgaria's national classification), which can enter Bulgaria only if they are:

- Bulgarian citizens and their family members, and residents in Bulgaria
- Citizens of EU and Schengen Associated countries and their family members





General information: shops and malls can only allow 1 person per 10 square metres. In shops larger than 500 square metres, an authorized person should check at the entrance that the maximum number of customers is respected. Mass events, gatherings, school events and celebrations, demonstrations, parades, concerts and festivals in public or private places are prohibited. However, entertainment venues, music and dance clubs can operate according to the following rules: Only holders of a negative lab rapid test result (valid 24 hours) and people who have received the booster or third vaccine dose can access. Distancing measures and health protocols are respected. Only seated service is provided and maximum 8 people can sit at a table. Dancing is prohibited. Venues operate at maximum 75% capacity with a maximum cap of 200 persons. Celebrations in schools and festive events in shopping malls (outdoors and indoors) are suspended. Gatherings in private venues are limited to 20 people, including minor children and hosts. Weddings, christenings, funerals and events in catering establishments and reception venues can be celebrated for holders of a negative lab rapid test result (valid 24 hours) and people who have received the third or booster vaccine dose with a maximum of 300 attendants. Conferences and trade fairs are allowed at 50% capacity of the premises, and in observance of the guidelines set out by the Ministry of Health. As of 28 December 2020, the SARS-CoV-2 antigen detection tests carried out by the mobile units of the Ministry of Health do not need confirmation by the molecular method (RT-PCR). Citizens with a positive test result will receive the self-isolation instructions via a text message. At the same time, the virus-positive person should inform his/her close contacts to self-isolate until the Epidemiological Monitoring Unit contacts them, and send a list with the details of his/her close contacts to contacttracing@moh.gov.cy. Hotels: Only people who have started or completed their vaccination scheme, and for who the period required for the administration of the second or third dose of vaccine has not elapsed, can visit or stay at hotels and tourist accommodations. Bars and restaurants: are open, however, the maximum number of persons allowed is 200, everyone must hold a valid SafePass, only seated service is provided, and a maximum of 8 people can sit at the same table. Travel restrictions: Cyprus is following a colour-coded system according to the epidemiological situation. All passengers have to submit, all the information and documents required to obtain the CyprusFlightPass within 48 hours before starting their journey. Travellers from orange countries can enter Cyprus if they provide a negative test result, performed by a certified laboratory within 72 hours before departure Travellers from red countries who enter Cyprus must provide a negative test result performed by a certified laboratory within 72 hours before departure AND perform an additional laboratory test immediately after they arrive in Cyprus. They must remain in guarantine until the result is available on www.covidtestcyprus.com/ Until 31 January, in addition to the regular protocol, all travellers older than 12 must: a) Provide a pre-departure molecular (PCR) test, valid 72 hours, or a rapid antigen test (valid 24 hours). b) Take another molecular (PCR) test upon arrival. Tests cost EUR15 at Larnaca Airport and EUR19 at Paphos airport. Results will be available within 3 hours on www.covid-testcyprus.com. Travellers who refuse to take this test must quarantine for 14 days, at own costs. Quarantine can end on day 7 if they take a molecular test.

c) Perform an additional rapid antigen test 72 hours after their arrival. These rapid antigen tests will be provided free of charge through the sampling points of the Ministry of Health, by showing the boarding pass and proof of identification. Travellers who were administered the booster vaccine dose are exempted.

Important: travellers from grev countries must guarantine for 14 days when they enter Cyprus, even if they are fully vaccinated. Only certain categories of travellers can enter Cyprus from grey countries. Currently, no EU or Schengen Associated countries are categorized as grey.



On 21.01.2022, 64,5% of the population received at least one dose of Covid-19 vaccine and 63,1% have been fully vaccinated.

COVID certificate: Czechia introduced the so called O-N-(T) system for a person to demonstrate meeting of the requirements for entry into the workplace, school, or service establishment. Since November 22, only proof of vaccination or proof of recovery are valid to enter indoor spaces including tourist accommodations, restaurants and bars, catering establishments, and leisure, cultural and sports facilities—negative tests are no longer sufficient.

General information: measures are diversified and tailored for every life situation. See here all different situations overview.

Certificates are required for entry to indoor venues, meetings and assemblies. Facemasks and respirators must be worn and the rules for social distancing respected. Churches are open for religious services. All shops and service points are open

Cinemas, festivals, and concerts can take place with a maximum of 1,000 spectators may be present. Spectators must be seated. In areas where more than 20 spectators are present, all spectators over the age of 12 must show a certificate. In addition, everyone present must have a respirator on at all times without an exhalation valve of min. class FFP2 (KN95 / N95).

Galleries and museums are open. However, the visitor capacity is limited so that people can keep a distance of 1.5 meters from each other.

Services, stores and their dispensing windows do not have limited opening hours. The stores can also be open on Sundays and public holidays (except for large public holidays, where the closing of shops is required by law).

The rules for quarantine and isolation, duration and exceptions, are explained on the Covid Portal.

Hotels: are open for those who can provide a covid certificate. It is obligatory to follow the governments accommodation rules. According to these, people without a certificate are allowed to book a stay for up to 7 days; they are obligated to meet the conditions again or to undergo an on-the-spot self-test after 7 days if they wish to stay longer. Accommodation services can also be provided to persons isolated or guarantined. In accommodation facilities, it is necessary to wear a mask class FFP2 / KN 95.

Bars and restaurants: All food service establishments may be open, subject to the governments rules. The operators must keep a distance of at least 1.5 meters between them, except for customers sitting at one table. There may be a maximum of 6 customers seated at one table, except for members of the same household. The operator must actively prevent people from congregating at a distance of fewer than 1.5 meters. This also applies to the waiting area of the business and provide disinfectant at the entrance.

Nightclubs may open. Live music is permitted in restaurants provided that customers keep a minimum distance of 2 metres from the designated performance area. Dancing is permitted for persons who have completed vaccinations, proof of illness, or a test up to 24 hours old prior to entry.

Travel restrictions: Travellers from all countries have an obligation to fill in the Passenger Locator Form before arrival. Countries are classified, according to their epidemiological situation.
Entry requirements depend on the colour attributed to the country of departure according to the Czech Republic's <u>national classification of risk areas</u> : green, orange, red and dark red. However, right now all travellers must provide proof of vaccination, recovery or a test result AND proof of either a booster dose <u>or</u> negative PCR test result.
The conditions of arrival of foreigners from countries with a low risk of infection (green category) and medium risk of infection (orange category) are being tightened in order to prevent the spread of the omicron. It will be necessary to undergo an <u>antigen or PCR</u> test from the green and orange countries <u>before</u> entry and <u>after</u> entering the territory of the Czech Republic on days 5-7 to undergo a PCR test.



General information: The Danish government has announced that practically all Covid-related restrictive measures are lifted as of 1 February 2022, including the use of a vaccine pass, mask-wearing and early closings for bars and restaurants. 
Bars and restaurants: are open. Discos and nightclubs can reopen.

Travel restrictions: With effect from Tuesday the 1st of February, the rules for entry into Denmark will be changed.

- Vaccinated and previously infected: Can enter without testing or isolation from all countries. However, requirements for testing and isolation are still in effect if you have been in a country / area with a virus variant of concern. At the present, there are no such countries or territories.
- Travelers who have not been vaccinated or previously infected: Must be tested within 24 hours of entry. When entering from a country in the EU / Schengen, you may instead choose to be tested before entry. Upon entry from COVID-19 high-risk countries, isolation is required for travellers who are not vaccinated or previously infected.
- Approved vaccines: The list of vaccines approved for entry into Denmark is expanded and now includes both EMA- and WHO-approved vaccines.

General information: Estonia remains open for travel and business. However, restrictions and special measures are in place to fight the pandemic. Facemasks must be worn, social distancing rules respected and COVID-19 certificates presented to access all indoor spaces and venues.

The risk level of the coronavirus spread can **be low, medium, high, or very high.** Indicators for risk levels, and ranges for them for each risk level have been established based on the recommendations of the Scientific Advisory Board and the Health Board. The seven day average number of people infected and hospitalised with COVID is taken into account. As of January 13, 2022 the level risk is very high

Commercial and service enterprises must ensure the dispersion of people, the availability of disinfectants and that disinfection requirements are followed in accordance with the instructions of the Health Board.

There is a temporary night-time movement restriction in force in public indoor spaces, which means that all events and activities have to end by 23.00.

The restriction does not apply to the opening times of stores and service areas of service providers, as well as selling food for takeaway at catering establishments.

For the entertainment sector and public events (including cinema, theatre, children's playrooms etc) up to 1000 people may participate in events and activities indoors, and up to 2000 outdoors.

Close contacts who live with a COVID-19 positive person or have come in contact with him have to remain in self-isolation for seven days, except if they have been vaccinated, recovered from the disease within the past six months or equated to a vaccinated person (i.e. recovered from the disease and been vaccinated).


Hotels: Tourist accommodations are open to visitors, with precaution measures in order to ensure people safety.

Bars and restaurants: Cafes, restaurants and catering establishments are open with restrictions, to visit them it is necessary to present a valid COVID certificate and wear a mask, except while eating.

Decisions on restrictions concerning events and gatherings are made by a municipality, or by a Regional State Administrative Agency if the decisions apply to several municipalities. The Government guides the community transmission areas to introduce all possible restrictive measures at low-risk events. Moderate and high-risk events should be entirely prohibited.

Hotels are open but many are forced to keep their services closed due to lack of customers as well as financial reasons.
Bars and restaurants: are open across with <u>restrictions</u> . These restrictions are valid from 12 January 2022. The restrictions on opening hours and the number of customers allowed in the premises vary by region. The restrictions may change depending on the development of the epidemic in the area. The restrictions will be reviewed weekly.
Restrictions on restaurants cannot be circumvented by using COVID-19 passport. Even if the use of the COVID-19 passport does not exempt restaurants from the restrictions as before, all restaurants in Finland will still have the right to require customers to present the COVID-19 passport at all hours.
Travel restrictions: it is necessary to have a certificate of COVID-19 vaccination series at least 7 days prior to entry, OR a single certificate that the person has recovered from COVID-19 and has gotten one dose of vaccine OR a certificate of recovery from COVID-19 less than 6 months prior to entry.
In addition, a negative result to a pre-departure molecular test or rapid antigen test (valid 48 hours) is also required.
Children aged 15 years or under are exempt from quarantine and testing requirements.
These measures are valid until 31st January 2022. Travellers are advised to consult current measures on Visit Finland.

Covid-19 pass validity and boosters: on 25.01.2022 49,4% of the population have taken an additional dose. Starting February 15, a booster dose will be required <u>four months</u> – and not the existing seven months – after the previous dose for the pass to remain valid.

General information: The current <u>health pass</u> has become a "vaccine pass" for those over 16 years old. It amplifies the conditions of control and toughen the penalties against false passes. New rules applies to tourists visiting France. While they don't need a booster to enter the country, they will need one to access venues where the health pass is required.

The use of teleworking is made compulsory for all employees for whom it is possible, for a minimum of three days per week and four days when possible.

From Monday January 3 and until January 23 inclusive, the spaces welcoming the public for shows or screenings can only accommodate a maximum of 2,000 people indoors and 5,000 people outdoors. In these spaces, the public must be seated and the consumption of food and beverages is prohibited. Standing concerts are prohibited. In cafes and bars, standing consumption is prohibited. Discotheques are prohibited from welcoming the public . This ban applies until the same date to dance activities in establishments open to the public, such as restaurants or bars.

Casinos are currently open without any gauge.

Entry to places of worship is not subject to the presentation of a "sanitary pass", unless shows or concerts are organized there.

The presentation of a "sanitary pass" is not required to go to a general practitioner or a specialist practicing in a town practice.



<u>Health protocols for tourism services and tourists</u>. <u>TousAntiCovid</u> is available since 2/6/2020. The App allows the user to be notified of possible close contact (less than 1 metre for at least 15 minutes) with someone who has then been tested positive to Covid. "

Hotels are open; a Covid-19 certificate is not required to stay. Breakfast may be served to guests who do not hold a pass.



Bars and restaurants: All bars, cafes and restaurants are open without time restrictions. But a Covid-19 certificate is required to access all catering establishments including terraces. Staff can request clients to show an ID in case of doubt in identity of the owner of the pass. Staff which are in contact with clients must also detain a valid pass. Health protocols must be always respected. From January 3rd and for a period of three weeks, consuming while standing will be prohibited in cafes and bars. A pass is not required for take-away orders.
Nightclubs and dance halls are closed until 24th January 2022 included. This ban applies until the same date to dance activities in establishments open to the public, such as restaurants or bars.
Travel restrictions: before entering France it is needed to perform a pre-departure molecular test or rapid antigen test within 24 hours of arrival except for those vaccinated coming from the Schengen area.
Entry requirements depend on the colour attributed to the country of departure, according to France's own national <u>classification of risk areas</u> : green, yellow or red areas / low, medium or high risk. Children younger than 12 are exempt from quarantine and testing requirements.
The EU-PLF form is for travellers arriving on the territory of a European Union Member State. While rules to fill the form may vary between EU countries, it is compulsory for travellers who wish to enter France. The Eos electronic form is for travellers coming from 'orange' or 'red' countries and territories.
In order to travel from an orange, red, or the UK a compelling reason is needed. Tourism and holidays abroad are not considered compelling reasons for travel . Green status will be granted/Considered if person is either fully vaccinated; with 72-hour validity negative PCR test; with 24-hour validity negative antigenfast test; or has had Covid-19 infection during past 6 months.

Covid-19 pass validity and boosters: on 09.01.2022 2% of the population have taken an additional dose

General information: In line with a decision made by the Coordination Council, citizens of Georgia will be allowed to enter the following facilities with a Green Passport from December 1, 2021the premises of establishments outlined above. As for the entertainment centres for children, Green Passport will be required from citizens aged 18 and older.

The Government of Georgia posts updates here.

On December 1, restrictions on restaurant opening hours were lifted.

The ban on concerts and festivals is removed so long as applicable regulations are observed.

Uniform wearing of facemasks has become mandatory both indoors and outdoors.

Restriction remains valid on holding the wide-scale entertainment and such social events, as wedding parties, banquets, jubilees of various types and similar.

Any type of entertainment activities, arts and culture events (except for stage performances and cinema), festivals are going to be fully banned. The referred restriction does not apply to concerts to be held at the premises of hotels. As for sports tournaments of various types, they may be held without spectators. Nevertheless, every participant should be vaccinated (14 days should be lapsed from the second dose) or have a PCR test result obtained in the past 72 hours or a negative result of an antigen test obtained in the past 24 hours.

Hotels: Most hotels and other rental accommodation are open. Face masks must be worn when entering public spaces inside hotels and rental accommodation.

Bars and restaurants: Restaurants and bars are open but restaurants. Night clubs remain banned both outdoors and indoors.

Travel restrictions: Foreign citizens are now allowed to enter Georgia under the following conditions:

Additionally, everybody aged above 6 must wear a face mask when using public transport or in public buildings and shops. Medical masks (surgical masks, KN95, or FFP2 masks) are required. Face masks should also be worn in places where social distance rules (1.5 meters) cannot be kept. Mask wearing is obligatory in schools for pupils from the seventh grade (12-13 years) upwards.

Hotels: Hotel are open but subjected to the 2G-rule. Details on restrictions in the federal states are available on the tourism guide.

Bars and restaurants: Restaurants, bars and cafés are open to the public but also subject to the 2G rule. Details on current restrictions in the federal states are available on the <u>tourism guide</u>. For example, <u>Berlin</u> now requires **2G+** which means "vaccinated with a booster vaccine", "vaccinated with a negative test", or "recovered with a negative test".

Travel restrictions: Germany classifies areas as: "high incidence" or "virus variant", areas.

All travellers over the age of six must exhibit proof of vaccination, recovery or a negative test result. Details in the section below. Travellers arriving from designated high-risk and virus variant areas must complete the <u>Digital Registration on Entry</u> form before they arrive. They must also provide proof of an antigen or PCR test. All <u>Passengers in transit</u> at German airports must possess proof of vaccination, recovery or testing.

- Only EU and Schengen Associated residents, and travellers from designated <u>low-risk countries</u>, can enter Germany for tourism or non-essential reasons. These travellers must provide the documents listed below. Travellers from all other countries can only enter if they are fully vaccinated or can provide proof of an important or urgent need to travel.
- Entry requirements depend on the country of departure according to Germany's classification of <u>international risk areas</u>: <u>high-risk areas</u> are where there is a high risk of infection due to the spread of COVID-19; <u>virus variant areas</u> are where there is a high risk of infection due to the widespread occurence of COVID-19 variants. Depending on their country of departure, and regardless of their vaccination status, travellers who have stayed in international risk areas must enter a 14-day quarantine on arrival.

Children younger than 12 years may end their quarantine after 5 days without submitting proof of a negative test result.

COVID certificate: The Greek Covid Pass app is designed to check customers' "safe" status and verifies whether an individual has been vaccinated, recovered from COVID or has recent negative PCR or antigen test results. The 'EU Digital COVID Certificate' (EUDCC) or an equivalent document is required to access some public spaces, including catering establishments, indoor venues and touristic attractions. Certificates must be accompanied by documents confirming the holder's identity, and contain one of the following:

- Proof of full vaccination
- Proof of recovery, valid between 30 days and 3 months after the first positive result. Certificates issued between 15 July and 31 October 2021 (included) remain valid.
- Only accepted in some cases (i.e. outdoor catering): negative test result.

Covid-19 pass validity and boosters: on 24.01.2022 44,8% of the population have taken an additional dose. From December 13, the vaccination certificate will not be valid seven months after its issuance for those over 60, unless they have a booster shot. From February 1 the certificate will expire at seven months for all adults

General information: There are four (4) levels of risk, depending on the epidemiological situation at each region or municipality, varying from 1 (low risk) to 4 (high risk). Currently, almost all country is at **level 4.** Specific protection measures can be applied to areas of the country classified as level 3 and level 4. The map is updated weekly and <u>can be consulted here</u>.

Live events (theatre or dance performances, concerts etc.) are held in open-air venues with seated guests only and at 65% - 75% capacity, depending on the size of each venue. Indoor venues (up to 85% capacity) admit visitors with a vaccination certificate, or with a Covid-19 infection medical certificate issued not sooner than 30 days after testing positive. Spectators have to purchase an e-ticket, wear a face mask, and respect the health and safety guidelines.

In archaeological sites, up to 20 visitors can enter together. This limit does not apply to families and to groups following a tour guide, which may include up to 40 individuals.

Cinemas, theatres and live events venues operate at 50% capacity (for a mixed audience) or at 75% capacity (for an immunised audience). Electronic tickets must be issued.

From December 30, all entertainment venues, bars and restaurants must close at midnight, have no standing customers and no music and allow a maximum of six people per table. Those without a vaccine certificate are barred from indoor venues such as bars, restaurants, cafes cinemas, theaters, retails stores and gyms.

Everyone needs to show a vaccination certificate and an ID to enter indoor places, but issues have been reported with vaccination certificates issued outside the EU, as the Greek digital system does not recognize them. Unvaccinated people are only able to enter certain essential indoor stores, such as pharmacies and supermarkets.

Hotels: are open. See here <u>Safety protocols for tourism services</u>. Tourist accommodation establishment managers are required to create an action plan, to have a health protocol in place for each part of the establishment and be ready to deal with a potential Covid-19 case, in accordance with the current guidelines of the National Public Health Organisation (e.g., hotel quarantine area).

Bars and restaurants: Until 23 January, restaurants, cafes and bars are open until midnight, and for seated customers only. The 'EU Digital COVID Certificate' (EUDCC) or an equivalent document is required to access restaurants, cafes, nightclubs, late-night bars, pubs. Certificates must be accompanied by documents confirming identity, and contain one of the following:

- Proof of full vaccination
- Proof of recovery, valid for 6 months after the first positive test
- Only accepted outdoors: negative test result to a molecular (PCR) test, valid 72 hours, or to a rapid test, valid 48 hours.
- Children aged 4-17, both indoors and outdoors, can also provide a negative self-test, valid 24 hours (self-declaration downloadable at self-test.gov.gr).

In addition:

- Maximum 6 people can sit at each table, both indoors and outdoors.
- Outdoors, 2 customers can sit at the counter, keeping a 1.5m distance from other customers.
- The use of facemasks is mandatory for customers waiting for a table, and strongly recommended for those already seated.

Travel restrictions: All travellers must complete their PLF before entering the country. Find more information on GreeceHealthFirst and travel.gov.gr.

In addition, all travellers must provide a negative result to a pre-departure test. Both molecular tests (PCR, valid 72 hours) and rapid antigen tests (valid 24 hours) are accepted and proof of full vaccination or recovery from COVID-19.

Only residents of EU Member States, Schengen Associated countries and of countries listed on <u>Greece Health First</u> can enter Greece for non-essential reasons. Travellers without a certificate of vaccination or recovery from Bulgaria must perform a test upon arrival. If the test is positive, they will have to perform a molecular (PCR) test to confirm the result.

Note: travellers selected randomly might be subject to **mandatory rapid antigen tests** upon arrival. Travellers who test positive must quarantine for 5 days, if they have no fever. Otherwise, they must remain in isolation until they have no fever. Quarantine is lifted when isolated travellers provide a negative result to a molecular (PCR) test.



Covid-19 pass validity and boosters: on 23.01.2021 36,7% of the population have taken an additional dose. Vaccines in Hungary have a validity of one year.

General information: there is no curfew in place or internal travel restrictions. Covid measures have been extended by the parliament until June 1, 2022.

Demonstrating protection against COVID-19 with a Hungarian immunity card, an 'EU Digital COVID Certificate' (EUDCC), a certificate recognized by Hungary or the EESZT application is mandatory to access all indoor events (sports, cultural, music and dance events, etc.), and outdoor events with more than 500 participants. Children younger than 18 are exempt if they are under the supervision of a holder of a protection certificate.

No minimum distance is required outdoors and indoors. Wearing facemasks is required in indoors public spaces, such as stores, shopping centres, post offices, health and social care institutions, public transport, theatres, cinemas, and at sports events. Worship places are allowed to be open. Weddings can take place up to 400 people and funerals may be organised with a maximum number of 100 participants. Stores are open. Wearing a facemask is required. It's possible to enter even without immunity certificate



Covid-19 pass validity and boosters: on 20.01.2022 61,1% of the population have taken an additional dose. Iceland has the second highest proportion of people who have taken the booster in Europe.

General information: The <u>Regulation</u> on restrictions on gatherings due the pandemic will apply from January 15 to February 2 2022. The maximum number of people allowed in the same <u>area</u> is **10 persons**, with certain restrictions, both in public and private locations, outdoors and indoors. Children are not excluded.

Performing arts, cinemas and other cultural events may have up to **50 persons** on stage, i.e. during rehearsals and shows. Up to 50 seated attendees, may be accommodated in a given area given they follow the rules for exceptions for 50 people at events, stated above.

At all workplaces and when performing other professional activities, individuals who are unrelated must keep a distance of 2 meters from each other.

At gatherings where all guests are seated 1 meter must be kept between guests, and a face mask must be worn.

Children born in 2016 and later are exempt from social distancing rules.

A separate <u>regulation</u> has been brought into effect for school activities. This regulation will remain in effect from 13 of January up to and including 2 February 2022.

Hotels: are open with limitation. To prevent the Coronavirus, <u>Icelandic hoteliers launched the 'Keeping it Clean'</u> program where a new standard is set when it comes to keeping hotels clean and ensuring the safety of guests and team members. The program is built on high-standard housekeeping procedures and official guidelines from local authorities.

Restaurants and bars: where alcoholic beverages are allowed may stay open until **21:00** all days of the week with a maximum of **20 guests** in each area and must maintain the 2 meter distance rule and 1 meter when seated. Alcoholic beverages are to be served to seated guests. All guests must have left the location at 22:00.



General information: According to the <u>State Chancellory</u> Latvia remains open for business and travel. However, strict rules and special measures are in place to combat the spread of the virus. COVID certificates are required for entry to indoor spaces and events. Rules for social distancing must be respected and facemasks worn in all indoor venues and at events where people congregate.

Due to insufficient resources, mainly human resources, a state of emergency has been declared in medicine:

- The State Emergency Medical Service carefully assesses which calls are more urgent.

- The State Emergency Medical Service takes patients to the hospital where the patient can receive the necessary treatment.

Restrictions will apply until 28 February 2022. These restrictions vary for vaccinated/recovered and unvaccinated people.

From 25 January, a mask or respirator must be used in the workplace, shop, public transport and other public places a medical mask, or respirator.

Only vaccinated or recovered persons can attend on-site to work and university.


Non-essential shops can only open from 6 am to 23 pm.



Only vaccinated or recovered people can access indoors or outdoors with a limit of no more than 4 people per table excluding minors and a distance of 2 m between tables. Delivery of food for take away is without a time limit and can also be provided to unvaccinated.

Travel restrictions: all travellers must complete a form 48h before entry: <u>Covidpass.lv</u>. Restrictions on entry to Latvia depend on the country the person is travelling from, as well as of proof of the fact of vaccination, testing or recovery from Covid-19.

- For persons with vaccination and/or Covid-19 recovery certificate: The Covid-19 test is not required; exception when returning from very high-risk countries. Self-isolation is not required, exception when returning from very high-risk countries.
- For persons without vaccination and/or Covid-19 recovery certificate: When arriving in Latvia from low-risk countries, a test must be performed before starting the trip, self-isolation does not have to be observed. When arriving from high-risk countries, a test must be performed before entering Latvia, as well as self-isolation must be observed upon arrival. When arriving from high-risk third countries, a test must be performed before and after entering Latvia, as well as self-isolation must be observed. In this case, an important reason for entering Latvia is required.



General information: Movement within the country is free, no curfews or movement restrictions are imposed. Facemasks and respirators must be worn at all indoor gatherings.

According to Lithuania's national tourism agency, hotels, spas, restaurants and other such tourist attractions remain open for people who are vaccinated or who have recovered from COVID, or who have taken a paid PCR or antigen test which is valid for 48 hours.

Certificates of entry are required. Rules for social distancing should be respected. There are currently no restrictions on the number of people who can gather at outdoor events.

Instead of the <u>National Certificate</u>, foreign tourists will be able to produce printed vaccination documents issued by other countries. Fully vaccinated foreign citizens are able to benefit from the National Certificate activities with the EU Digital COVID Certificate. Foreigners with a negative coronavirus test carried out in Lithuania will also be able to get more services; yet, they will have to do the testing at their own expense. The test will be valid for 48 hours from the time of taking the sample after the PCR pay test or antigen pay test.

Hotels: Tourist accommodations are open. Certificates are required for entry. Facemasks and respirators must be worn. Rules for social distancing should be respected.

Bars and restaurants: Restaurants, cafes and bars are open only for holders of National Certificate without limitations. Non-holders of National Certificate are not allowed to enter catering establishment. Face masks are mandatory in indoors shared spaces. Night clubs other dancing venues resumed their activities.

Travel restrictions: All travellers entering this country must complete the Passenger Questionnaire 48 hours before arrival.

Entry requirements depend on the colour attributed to the country of departure, according to Lithuania's national classification of risk areas:

- Passengers arriving from red, grey and black countries/areas must self-isolate for 10 days and follow mandatory isolation regulations.
- Passengers from red or grey countries/areas, if they are vaccinated or recovered, need not comply with testing and self-isolation requirements
- Passengers arriving from orange and green countries do not have to self-isolate.

Covid-19 pass validity and boosters: on 22.01.2022 49,9% of the population have taken an additional dose. The general <u>validity</u> period of vaccination certificates is set to 270 days (<u>9 months</u>) from the date when the vaccination pattern is considered complete. For the time being, and pending further decisions at EU level, the validity period of vaccination certificates issued following a booster vaccination is not determined. The <u>Government Council of 15</u> <u>December</u> decided to reduce the interval between the last injection of a Pfizer or Moderna vaccination and the "booster" dose from 6 to <u>5 months</u>.

General information: information on the situation in the country is available on the official website on COVID-19 information.

Luxembourg has the <u>CovidCheck system</u> in place, applicable to private persons, establishments (e.g. restaurants, bars, fitness centres, shops, administrations, companies, etc.) as well as public or private events (e.g. sports events, concerts, etc.). Under the currently applicable "**2G+**" system, persons who have reached the age of 12 years and 2 months must present a certificate of vaccination or recovery and either perform a self-diagnostic test for SARS-CoV-2 on site or present a valid NAAT or certified valid SARS-CoV-2 rapid antigen test.


Persons who have a vaccination certificate issued within the last 180 days, a certificate of the booster vaccination, or a recovery certificate for a period of 180 days are exempt from the testing obligation. Persons who cannot be vaccinated for medical reasons must present a certificate of contraindication to vaccination, as well as a certificate of a negative COVID-19 test (PCR, certified antigen test) or, if necessary, perform a self-test on site.

Since 15 January 2022, the "3G" system is compulsory in the workplace (private and public sector). Travellers are strongly advised to always carry relevant certificates.

<u>Public gatherings</u> of more than 200 people are prohibited, unless they are subject to a health protocol accepted in advance by the Health Directorate, which determines the health measures to be observed.

For gatherings of up to 10 people, there are no mandatory restrictions or health measures to be observed. For gatherings between 51 and 200 people, seating must be provided.
Any gathering between 11 and 20 people may be conducted under the CovidCheck plus (2G+) system notified in advance or otherwise it must be ensured that people wear masks and observe a minimum distance of 2 metres.
Any gathering between 21 and 200 people, the CovidCheck 2G+ system applies, which means that people as from the age of 12 years and 2 months must provide proof that they are vaccinated or have recovered from COVID-19 and take a COVID-19 self-test.
Sports activities carried out in groups of more than 10 are subject to the mandatory CovidCheck ("2G+") regime
Health protocols for tourism services and tourists (in English).
Hotels: Hotels and other accommodation facilities are open. Catering services provided in hotels are subject to the same rules as those applied for restaurants, bars and cafés. The 2G-rule (vaccinated or recovered) is in effect. An identity check can be carried out. Young people aged 12 years and 2 months to 15 years will be subject to the 3G regime (vaccinated, recovered, tested).
Bars and restaurants: are open until 11 PM. Restaurants, bars and cafes are subject to the CovidCheck Plus ("2G+") system. Clients who have reached the age of 12 years and 2 months must present a certificate of vaccination or recovery and either perform a self-diagnostic test for SARS-CoV-2 on site or present a valid NAAT or certified SARS-CoV-2 rapid antigen test. The test is not mandatory for people who completed their vaccination pattern less than 180 days ago, for people who have received their "booster" dose and for people with a recovery certificate. This applies to both indoor and outdoor use.

- Children between 12-18 who have not yet been offered the booster shot
- Children under 12
- Mothers in their first trimester
- Medical reasons that have prevented you from taking the booster

Hotels are open. Standards for hotels and similar establishments.

Bars and restaurants : There is a limit of 8 people per table in hospitality establishments, and no social distancing between tables is required. Masks are to be worn inside, unless seated and eating or drinking.

General information: Overview of rules and recommendations. In areas characterised by a higher epidemiological risk, further restrictions may apply: Local measures. The national government explicitly advices to accept vaccine doses, stay home and get tested when sick.

Whenever practically feasible, the employer should arrange for employees to be able to work from home when this will not hamper important and necessary activities at work.

Outdoor gatherings are limited to a maximum of 100 participants. With designated seating: Up to 3,000 participants and a maximum of 50 percent capacity.

This also includes persons who are vaccinated or have had COVID-19.

Hotels are open. Persons who are not permanent residents (as per the National Population Register) or do not have a suitable place of residence to implement their travel quarantine, must complete their quarantine duty period at a quarantine hotel.

Bars and restaurants are open with restrictions. The venue must make sure all guests are able to keep a one-metre distance and close the serving of alcohol at 11.00 PM (23.00). Serving of alcohol should only take place at the table. The venue should make sure all guests can keep a distance of one metre to other guests, except those who are part of the same household or similar close contacts.

Wearing a face mask is mandatory when keeping a distance of one metre is not possible, except when seated at the table.

Venues cannot arrange activates where the participants have less distance than one meter each other – such as dancing.

Up to 100 people may participate in events and meetings (including weddings and other celebrations), either outdoors, indoors or in designated areas. People who hold an 'EU Digital COVID Certificate' (or equivalent documents) are not included in this limit.

The limit of people in religious worship places, cinemas, art galleries, theatres, concerts, museums and libraries is a maximum of 30% occupancy. People who hold an 'EU Digital COVID Certificate' (or equivalent documents) are not included in this limit.

Shopping centres and retail stores are open. A strict sanitary regime is in place and customer capacity is limited (1 customer per 15 square metres). People who hold an 'EU Digital COVID Certificate' (or equivalent documents) are not included in this limit.

Gyms, fitness clubs and solariums operate under a sanitary regime. A limit of 1 person per 15 square metres must be respected.

People who hold an 'EU Digital COVID Certificate' (or equivalent documents) are not included in this limit. Access can be denied to people who do not hold an EUDCC.

Night clubs, discos and other dancing venues are closed.

Travel restrictions: All passengers flying to Poland must fill in a <u>Passenger Locator Form</u>. Travellers can enter Poland without being subject to testing or quarantine if their 'EU Digital COVID Certificate' (EUDCC) contains one of the following:

• Proof of full vaccination

Validity: **14 days** after the last dose required was administered (counting from the day following the last dose. Hotels: Holding an 'EU Digital COVID Certificate' is mandatory. The 'Clean and Safe' seal was implemented to increase security in accommodation establishments and touristic attractions. See further details at:





General information: The measures and restrictions in a given district may change according to the local epidemiological situation, as set out in a framework known as the '<u>Covid Automat</u>'. Each district of Slovakia is evaluated every week according to its epidemiologic situation. There are 5 different levels of alert.

There are four different regimes based on vaccination:

1. Basic (all persons);

2. **OTP** (vaccinated, tested, recovered);

3. **OP** (vaccination/primary series, recovered/maximum 180 days after recovery);

4. OP+ (vaccinated with a booster, primary vaccination series + test; primary vaccination series + recovery/maximum 180 days after recovery).

All non-essential shops and services are open. The regime they operate under depends on the level of risk involved in the types of services they provide.

Respirators must be worn indoors. Travellers are reminded to always carry their certificates of vaccination, recovery or negative test result.

There are three types of events and gatherings with different rules according to the potential risk of infection.

Low-risk: Maximum capacity of 100 persons, or 50 percent of the capacity of premises under strict rules (only vaccinated and recovered persons wearing respirators). Low-risk events include cinema and theatre performances where there is no risk of eating.

<u>Medium-risk:</u> Maximum capacity of 100 persons, or 25% of the capacity of premises under strict rules (only vaccinated and recovered persons wearing respirators). Medium-risk events include cinema and theatre performances with the possibility of eating.

High-risk: Maximum capacity of 20 persons (vaccinated or recovered persons). High-risk events include wedding celebrations, parties, etc.).

Museums, galleries and exhibition halls are open. They operate under strict limits for vaccinated and recovered persons (OP regime).

Cinemas, theatres and other cultural facilities are also open (under the rules of the OP regime)

Personal care businesses are open for vaccinated and recovered persons under the OP regime.

Fitness facilities, wellness centres and swimming pools are open under the OP+ regime

Hotels: Tourist hotels operate under the rules of the OP+ regime (vaccinated with a booster, or two series vaccination + test, or two series vaccination + recovery/no more than 180 days ago). Hotel facilities such as restaurants and wellness businesses are open under strict limits. If not vaccinated, children from the age of 6 to 12 are required to have a test. Children under the age of 6 are not required to have a test.

Restaurants and bars: Catering establishments are open. They operate under strict limits for the vaccinated from 5:00 until 10:00 (OP regime).

Take-away businesses are open for the unvaccinated.

Travel restrictions: All travellers entering this country must complete a <u>Registration Form</u> and, if arriving by air, a <u>Passenger Locator Form</u>. They must show proof of vaccination, recovery or a negative test result.

- To avoid quarantine, 2-dose vaccines must be completed at least 14 days (and a maximum one year) after the second dose, while 1-dose vaccines must be completed at least 21 days (and a maximum one year). For recovered persons, the time period is 14 days and a maximum one year after administration of the first vaccine dose (if administered within 180 days after recovery).
- Mandatory quarantine is in effect for all travellers (regardless of vaccination status or recovery) who have visited the following countries in the last 14 days: South Africa, Botswana, Namibia, Lesotho, Eswatini, Mozambique, Zimbabwe, Israel, Hong Kong and Seychelles. The <u>Public Health</u> Authority provides these travellers with rules for quarantine and testing requirements.

Children below 12 and 2 months are exempt from quarantine and testing requirements. Learn more: Public Health Authority


Covid-19 pass validity and boosters: on 23.01.2022 27,8% of the population have taken an additional dose. For persons over 18 years of age, vaccination and recovery certificate will be valid if they are not older than 9 months. Vaccination certificates issued after a booster dose will also be considered as proof of vaccination, with the exception of the vaccines Vaxzevria (COVID-19 Vaccine) manufactured by AstraZeneca and Covishield manufactured by Serum Institute of India/AstraZeneca.

General information: General measures against coronavirus infection.

The Government ordinance stipulates that the **Recovered - Vaccinated – Tested rule (RVT rule)** must be met by all employees as well as all users of services or activities.



Gatherings (socialising) are temporarily prohibited , and are only permitted for groups of persons who are immediate family members or share the same household. All public events, public gatherings, celebrations, and wedding ceremonies are temporarily prohibited , unless otherwise provided for in ordinances or other acts of the Government of the Republic of Slovenia.
The organisation of public cultural events in open public spaces is not permitted , but it is permitted in enclosed public spaces with fixed seating, whereby every other seat must be left vacant, the use of face masks is mandatory, and all participants must comply with the recovered/vaccinated/tested rule.
The organisation of public sports events is allowed only in spaces with fixed seating, whereby every other seat must be left vacant, the use of face masks is mandatory, and all participants must comply with the recovered/vaccinated/tested rule.
The collective exercise of religious freedom is permitted provided that participants comply with the recovered/vaccinated/tested rule, wear protective masks and maintain a distance of 1.5 metres between each other.

Hotels: Tourist accommodations are open. The 3G-rule (vaccination, recovery, tested) is in effect. Undergoing quarantine at tourist facilities is not possible under any circumstances.
Bars and restaurants: catering is open only from 5h to 22h. The use of a mask is not required for guests sitting at tables, only when observing the RVT condition. At the entrance of an establishment or premises where the hospitality activity of serving food and beverages takes place, the maximum number of guests permitted simultaneously in the establishment or at the premises must be displayed in a visible location.
Bars and clubs are <u>closed</u> .
Travel restrictions: all travellers need the following document checklist:
 Passenger Locator Form. Proof of vaccination, recovery or a negative COVID-19 test result. Travellers who are not vaccinated or recovered must present either a PCR test no older than 48 hours, or an antigen test no older than 24 hours. <u>Travellers who cannot provide at least one document must self-isolate on arrival for seven days</u>. Quarantine ends when they can provide a negative PCR test result from the fifth day.
Children younger than 12 years are exempt from quarantine and testing requirements. Travellers are advised to consult current measures at the Ministry of the Interior.

General information: Specific regional regulations are in place - please, consult the relevant webpages.

Facemasks are mandatory in public spaces indoors. Its use is also mandatory on all means of public transport, as well as in private vehicles if the occupants do not live together at the same address. Exceptions are made for children under the age of six and for people with disabilities or respiratory illnesses.

Outdoor social gatherings are limited to six people. Physical distancing measures must be guaranteed and maximum precautions must be taken to avoid meetings and overcrowding in indoor places.

Shops must ensure that disinfection measures and social distancing are applied. Special attention is required in commercial areas and street markets.

The contact tracing app Radar Covid is currently being rolled out in regions across Spain after a pilot test in La Gomera.

Guide of regional and local restrictions (in Spanish).

Hotels: Occupancy is often limited, especially at the reception and in common areas. There can be restrictions on valet parking and ironing services. In-house catering services have to comply with the general disinfection and social distancing measures, as well as restricted opening hours. There may be temporary limitations on the number of guests per table. All tourist services should ensure everyone's safety, based on three essential principles: social distancing, hygiene, and responsible behaviour. Measures may be changed when necessary to respond to the local COVID-19 situation.

Bars and restaurants: Autonomous Communities are the competent authorities regulating access to these places, and the 'EU Digital COVID Certificate' (or equivalent) could be required to access indoors bars and clubs. Please, consult <u>here</u> current restrictions in every region (in Spanish).

In general, social distancing of 1.5 metres at the bar is mandatory, and tables should at least be 1.5 metres apart. For restaurants, limits of persons per table applies and indoor dining is limited, according to the rules in place in different autonomous regions. Masks shall remain on when not eating or drinking.

Nightclubs remain open in Madrid whereas in Catalonia are closed.

	The wearing of masks is mandatory at all times outside the home throughout Turkey. This includes, but is not limited to, all public places, including streets, side streets, parks, gardens, picnic areas, markets, sea side and public transportation including Metro, buses, taxis and ferries. Masks are also mandatory in a shops, restaurants, hairdressers and barber shops.					
	Turkish citizens and residents must have proof of either two Covid vaccinations or recent Covid recovery (linked to the HES code) or a negative PCR test (within 48 hours) for entry to cinemas, concerts and events, as well as for intercity or inter-provincial domestic travel.					
	Hotels are open. Restaurants in hotels/accommodation facilities are open for all guests.					
	Bars and restaurants: Dining establishments such as restaurants, patisseries, cafés, and cafeterias is open for in-person dining and delivery services. Restrictions still apply in hookah bars and lounges.					

Travel restrictions: All incoming passengers must complete a "Traveler Entry Form" at least three days before their arrival in Turkey.

Travelers from all other countries must present proof of vaccination against COVID-19 completed no less than 14 days prior to arrival or proof that they have recovered from COVID-19 in the previous six months. Travelers unable to meet these requirements must present a negative result from a PCR test taken in the previous 72 hours or a negative result from an antigen test taken in the previous 48 hours on arrival.


COVID certificate: setting out plans to lift the "Plan B" measures which were put in place to tackle the rise of Omicron, Boris Johnson told MPs that Covid certification would no longer be compulsory from Thursday 27 January. From 26 January, in North Ireland its Covid passport scheme will no longer be mandatory for pubs, restaurants, cinemas and theatres - although venues are being encouraged to carry it on. Scotland's First Minister Nicola Sturgeon has confirmed that its Covid pass scheme will not be extended to cinemas and theatres for the time being. However, they are still required for nightclubs and large events - such as football matches - which are now allowed once more. Covid vaccine validity and boosters: on 23.01.2022 54,2% of the population have taken an additional dose. Anyone over 17 years old can get a booster dose in case they have had a 2nd dose of the vaccine at least 3 months ago. For those who have a weakened immune system and have had a <u>3rd dose of the vaccine</u>, it is possible to get a booster dose from 3 months after their 3rd dose.

General information: the four home nations (England, Scotland, Wales and N. Ireland) apply measures differently.

- England will exit its <u>Plan B</u> contingency from January 27. After this, face masks will no longer be mandated anywhere and COVID passes will no longer be required for large events, and teleworking guidance will be lifted. Sajid Javid, the health secretary, explained that that the Omicron variant is "in retreat". Amongst the changes, the working from home guidance was revoked with immediate effect. The compulsory wearing of face masks will be removed across all venues and settings as of Thursday 27 January. An additional significant change is that as of Thursday 27 January, Covid passes will no longer be compulsory at large events.
- In Northern Ireland, people must show vaccine passports for venues including nightclubs, bars and cinemas, and there's a limit of 30 people from different households mixing indoors in domestic settings. Coronavirus restrictions Northern Ireland were eased on 21 January in response to falling cases of infection.
- In Scotland, people must provide their contact details in order to enter indoor hospitality businesses, and all over-18s must prove they are fully vaccinated in order to enter nightclubs and other venues. Attendances at football and rugby matches had been limited to 500 people under rules which were introduced as cases of the Omicron variant surged across the country.





 In Wales, people must show their NHS COVID Pass in order to enter nightclubs, cinemas, theatres, concert halls and many other events. The U.K. Health Security Agency urges people to take a rapid COVID test before socializing. From 28 January, working from home, while still advised, will no longer be a legal demand. Rules around self-isolation and face masks will remain in force, with a review of all measures on 10 February.
Hotels: Hotels, hostels and B&Bs are open across the UK
Bars, pubs, cafés and restaurants: are open. That said, in Scotland rules on indoor events and venues, including the need for table service in hospitality premises, will be lifted from 24 January, when nightclubs will also be allowed to reopen. In Wales, from 26 January, nightclubs will be able to reopen and vaccine passports will no longer be required to go into venues like pubs, restaurants and cinemas.
Nightclubs are open and require a Covid pass, except in Scotland, where they will close from 27 December.
Travel restrictions: All inbound travellers must submit a passenger locator form 48h within arrival.
Pre-departure coronavirus tests are no longer be required for vaccinated travelers to England and the requirement to self-isolate also has been lifted. A test on the second day after arrival is still required. Vaccinated travelers can choose to take a lateral flow test on their second day instead of a PCR test.
Unvaccinated travelers entering the U.K. must have a negative predeparture test (PCR or antigen) taken in the two days before their travel; and they must take a PCR test on the second day after arrival and must self-isolate until they have a negative result. The test must be booked and paid for before arrival.
